Personal Details

Enter your personal details such as name, country of citizenship, residence, passport, etc.

Contact Information

- **Current Mailing Address.** Full address including apartment number if applicable.
- **Resident Address.** If your mailing address is the same as where you live, answer "yes," otherwise enter the full address of where you live.

Details of Intended Study

- **Level of Study.** Select appropriate university level.
- **Designated Learning Institution Number.** McMaster University is 019395535729; McMaster Divinity College is 019395535687.
- **Duration of Expected Study**
 - **From YYYY-MM-DD.** Enter program start date
 - **To YYYY-MM-DD.** Estimated date of program completion plus 90 days
- **The Cost of My Studies Will Be:**
 - **Tuition.** Enter tuition for one year only.
 - **Room and board.** \$10,000.
 - **Other.** Any other funds available to you.
- **Funds Available for My Stay (CAD).** The amount indicated should be the same amount or less than the amount indicated in your proof of funds.
- **In addition to a study permit, are you also applying for a work permit?** Yes or No.
- **What type of work permit are you applying for?** Co-op work permit (for students accepted into a co-op/internship program).

Education

Have You Had Any Post-Secondary Education (including university, college or apprenticeship training)?

Answer yes if you have a previous undergraduate degree from any country.

Employment

List any work experience you have in the last 10 years, if no work experience, enter your last education

- **Background Information.** Answer all questions truthfully.
 - If you have studies or worked without a valid study or work permit, you will need to provide the details.

- If you have been refused a visa or admission to Canada or any other country in the past, provide a brief explanation.
- **7C: Have you previously applied to enter or remain in Canada?** Yes. List all visa/permits previously applied for and when e.g. Visitor Visa Aug 2017
- **Signature.** You need to validate the form and save on your computer if completing an online application. If you are submitting a paper application, be sure to validate before you print it out to sign.
