**UCI.** Unique Client ID – 8 or 10 numbers in the format XXXX-XXXX or XX-XXXX-XXXX listed on your current study or work permit.

## Visa Requested:

Visitor Visa.

## Personal Details

- **Current Country of Residence.** Canada.
- **Status.** Student (Worker if on a Post Graduate Work Permit).
- **From** YYYY-MM-DD. The first day you arrived to Canada.
- **To** YYYY-MM-DD. Study permit expiry date (PGWP expiry date if applicable).

## Contact Information

- **Current Mailing Address.** Full address including apartment number if applicable.
- **Resident Address.** If your mailing address is the same as where you live, answer “yes,” otherwise enter the full address of where you live.

## Details of Visit to Canada

- **Purpose of My Visit.** Returning Student. (Returning Worker if on PGWP).
- **Indicate How Long You Plan to Stay**
  - **From** YYYY-MM-DD. Enter today’s date.
  - **To** YYYY-MM-DD. Expiry date of study permit or PGWP.
- **Name, Address and Relationship of Person(s) or Institutions(s) I will Visit:**
  - **Name.** McMaster University.
  - **Relationship.** School.
  - **Address.** 1280 Main Street West. For PGWP applicants, if currently working, enter employer address.

## Education

**Have You Had Any Post-Secondary Education (including university, college or apprenticeship training)?**

No. Answer yes if you are a graduate or transfer student and include the requested information.

## Employment

- **Current Occupation/Activity.** Student.
- **Employer.** McMaster University. There is no need to enter part-time work. For PGWP applicants, if currently working, enter employer address.
- **Background Information.** Answer all questions truthfully.
  - If you have studies or worked without a valid study or work permit, you will need to provide the details.
  - If you have been refused a visa or admission to Canada or any other country in the past, provide a brief explanation.
- **7C: Have you previously applied to enter or remain in Canada?** Yes. List all visa/permits previously applied for and when. For example, Visitor Visa Aug 2017.
